For the last years, reforms have been launched in the Airlines, Telecoms, Internet, Electricity, Postal & Transportation networks systems, towards a liberalization or re-regulation of these systems, trying to make them more competitive, more efficient. New economic approaches have been brought into these traditionally regulated sectors, and this implies a subsequent need of well trained professionals in order to manage both the transition and the new systems.

The program is supported by the European Commission Erasmus Mundus programme, mainly through the funding of scholarships for third-country students and scholars other than the 27 EU States, EEA / EFTA and candidate countries for accession to the EU.

Scholarship

More than 20 scholarships, funded by the European Commission, are available for highly qualified third-country graduate students.

For each student the scholarship amounts to 21,000 Euro per academic year.



■ **Degree offered:** Our Erasmus Mundus program will deliver **multiple diploma**. Students will receive the diploma of each university where they have studied:

French Master of "Economics, Technology and Territory" degree

Spanish Master "Electricity Sector" degree

Dutch "Master of Science in Engineering and Policy Analysis" degree.

■ **Linguistic competencies:** Students have to follow courses in English (Delft, Comillas and Paris XI), French (Paris XI) and Spanish (Comillas).



■ A high level of English is required (IBT 550 TOEFL score (English test) of at least 71 or IELTS (academic version) overall Band score of at least 6.0), plus a knowledge of French and/or Spanish.

Contents, structure, previous studies and mobility

- **START: SEPTEMBER 2008**
- **DURATION: TWO YEARS FOR A MAXIMUM OF 120 ECTS**
- **TUITION FEES: 9,500€ PER YEAR (19,000€ FOR THE WHOLE MASTER PROGRAM)**

Students are required to study in at least 2 different countries and in a maximum of 3 different countries. If they choose to attend Delft University, they have to stay there for at least a year

Students must have obtained a BSc diploma (or equivalent) of substantial quality and level corresponding to minimum 3 years studies at University, equivalent to 180 ECTS. They must have studied Engineering, Economics or Management (for studying at Delft, these studies must be in a technological field or the natural sciences).

Each student in our program is asked to choose between 3 complementary options to have our Masters degree. Students coming from different programs can select two or three areas of complementary specialization. The courses offered by the Consortium are detailed in the web site, specifying the different options a student has for organizing his/her four semesters in the different institutions. At the end of their thesis, students will be required to present their research results in the university; presentation of research reports may also be invited in a dedicated research seminar to be held at the Florence School of Regulation.
